



Application guidelines Digital Labs: teachers of social and humanitarian sciences from Eastern Ukraine

1. Ноизе оf Еигоре

House of Europe is a EU-funded programme fostering professional and creative exchange between Ukrainians and their colleagues in EU^{*1} countries. The programme focuses on culture and creative industries, education, health, social entrepreneurship, media, and youth.

This encompasses 20+ separate programme lines enabling us to go for conferences, professional events, internships, and networking in the EU*, or to enrol in study tours, residencies, training, and other forms of support. House of Europe funds cultural coproductions and cooperations between Ukrainian and EU* organisations, along with the development of cultural infrastructure and artistic concepts for youth in Ukraine. Finally, the programme offers various youth camps and an intra-Ukrainian university exchange.

Implementation of House of Europe is led by Goethe-Institut Ukraine, with The British Council, Institut français, and Czech Centres as consortium partners.

2. Digital Labs: teachers of social and humanitarian sciences from Eastern Ukraine

Digital Labs bring together educators from all over Ukraine to overcome common challenges of teaching social and humanitarian subjects and introducing conflict mediation to your curriculum.

You will learn about the effective solutions during lectures with experts from the EU* and Ukraine, come up with new ideas during workshops, and in a team with other participants will design and present a solution to a pressing issue of modern education.

Members of teams that prepare the best methodologies will get stipends of up to EUR 500 for further professional advancement.

3. What is the structure of the Digital Lab?

- Lectures and workshops, where you will learn know-how and practical work tools from peers
- Work in groups, where, together with other participants, you will develop methodological recommendations solving the challenges of the Digital Lab
- Mentoring sessions with experts, where you will receive advice on the methodological recommendations you are working on
- Presentations of methodological recommendations you created in a team with other participants to a jury where you will get an outside view and the opportunity to compete for scholarships for further professional advancement

4. Who teaches at the Digital Lab?

The Digital Lab experts are leading education professionals from the EU* and Ukraine: heads of chief educational institutions, authors of new methodologies, gifted professors and teachers.

5. What should I prepare for the final presentation of the Digital Lab?

During the Digital Lab, you, in team with other participants, have to create methodological recommendations that will solve one of its challenges.















For each topic, we identify the most pressing challenges. For instance, participants of the Digital Lab dedicated to the digitalisation of primary education worked to mitigate the lack of means to control the quality of learning material by students in online education.

You and your teammates must submit a presentation and a short text explanation. For your convenience, we will share templates for these documents.

6. How does Digital Lab work₹

The Digital Lab will take place online via Zoom. Please have your camera and microphone switched on during lectures and workshops.

You can keep in touch with other participants via our Viber chat.

7. What is the duration of the Digital Lab?

The Digital Labs lasts nine days:

- Four days of intensive training taking place on weekends from 09.00 to 19.00.
- Five days of work on methodological recommendations and mentoring sessions taking place on weekdays from 15.00 to 20.00.
- One day of the projects' presentations to a jury.

B. What is the working language of the Digital Lab?

During the Digital Lab, you will communicate in Ukrainian. It will be the working languages of lectures, workshops, mentoring sessions, and the final presentation.

We invite translators so that you understand the lectures of EU* experts. They will also be there for you during mentoring sessions.

9. When will the Digital Lab take place₹

The Digital Lab dedicated to innovations in teaching social and humanitarian sciences will take place from 7 to 15 May 2021.















10. Who can participate in the Digital Lab?

- School teachers of socio-humanitarian subjects participating in education reform and interested in developing methodology of reaching conflict mediation skills
- Headteachers interested in working with students from conflictaffected areas of Luhansk and Donetsk oblasts
- Specialists in the sphere of education working on methodologies of teaching basics of humanitarian law and conflict mediation

11. What are the requirements for participants?

- At least three years of experience in the field of education
- Ukrainian citizenship²
- At least 18 years of age

We only accept individual applications. You will not be able to apply in a team.

12. How to apply₹

To apply, you should submit an application along with supporting documents via our <u>online platform</u>.

You must submit your application using the 'Submit entry' button by Tuesday 30 November 2021, 15.00 Kyiv time.

Be careful, as you will not be able to submit the application after the deadline.

13. How do I register on the online platform?

You have to register on the online platform to be able to fill in an electronic application.

Your email address is required. We will use that email address as an official channel of communication with you, so register on the online platform with an email address you check regularly.

When registering, make sure to put a tick in the field: "I agree to receive notification and communication emails or SMSs from House of Europe. You may withdraw your consent at any time." You will not be able to receive important communication from us regarding the status of your application if you do not provide your consent.

15. What additional documents do I need to provide?

 CV of two pages maximum in PDF: professional experience, education, internships, scholarships, and awards. Please draft the document in the Ukrainian language.

- Two letters of recommendation signed with blue ink. Letters should be from experts in your field, your current or previous employers.
 Please draft the document in Ukrainian or English language.
- A copy of the first page of the passport³. We will check whether you are of full age and have Ukrainian citizenship.

Please note that if you do not attach the requested documents, we cannot consider your application.

16. How many applications can I submit?

- You can only submit one application. If you submit multiple applications, we will consider the first one.
- You cannot apply if you have already participated in Digital Labs: educators.

17. How will my application be evaluated?

Your application will go through two stages of assessment.

First, your application will be reviewed technically to confirm that it was submitted on time, includes answers to all questions on the application form and has the mandatory attachments.

If your application is compliant with that, our experts will evaluate it according to the following criteria.

• Your application will go through the technical review and assessment by the experts. It takes several weeks.

- You will receive the results of the assessment through an email sent by the end of December 2021. We will send a notification to the email address you used to register on the online platform.
- If your application is successful, we will ask you to provide a short bio. Later we will also share an email with the date of the first session, a link to the Zoom conference, and additional materials.

19. What if my application is unsuccessful?

We receive a larger number of excellent applications than we can fund, thus not all the applications will be successful.

If you do not succeed this time, you can apply for the next open call for Digital Labs: educators or apply for other House of Europe opportunities. You can find more than 20 programmes on <u>our website</u>.
