



Call for a partner Development of two pedagogical programmes for European Youth Camps

1. Ноиѕе оf Еигоре

House of Europe is a EU-funded programme fostering professional and creative exchange between Ukrainians and their colleagues in EU*1 countries. The programme focuses on culture and creative industries, education, health, social entrepreneurship, media, and youth.

This encompasses 20+ separate programme lines enabling us to go for conferences, professional events, internships, and networking in the EU*, or to enrol in study tours, residencies, training, and other forms of support. House of Europe funds cultural coproductions and cooperations between Ukrainian and EU* organisations, along with the development of cultural infrastructure and artistic concepts for youth in Ukraine. Finally, the programme offers various youth camps and an intra-Ukrainian university exchange.

Implementation of House of Europe is led by Goethe-Institut Ukraine, with the British Council, Institut français, and Czech Centres as consortium partners.

2. What is this call about?

We are looking for a partner to develop two pedagogical programmes for European Youth Camps:

"Learning to live together: me and society" for children aged 11-13 years

The pedagogical programmes must be a combination of education and fun and serve as a guide for animators.

3. What are European Youth Camps?

<u>European Youth Camps</u> are camps with a focus on values important to European and Ukrainian society. The target audience of the camps are children aged 11-13 years and 14-16 years.

For each camp we choose an important topic and explain it to children in an interactive way. Among these topics are ecology, sustainable development, health, tolerance, inclusion and democracy. Children learn, make friends and have fun.

The participants also have access to a specially designed mobile application with additional information, quests, and games. The application operates on iOS and Android.

In 2021, the selected topics were "Tolerance and inclusion" and "Ecology and sustainable development".

4. What are the formats of the European Youth Camps?

European Youth Camps might be developed in up to three different formats:

- Offline European Youth Camps within leisure or health camps structures that last for 14 days. It requires development of 12 daily topics based on the selected thematic, on a full accommodation basis calendar (24 hours on-site), including pedagogical activities in a formal and non-formal education format, and playful activities in relation with the selected thematic (theatre, collective games, arts, sports, excursions, etc.)
- Nomad European Youth Camps within the premises of educational organisations or school institutions that last for 5 days. It requires selection and development of 5 daily modules based on the thematic, on a half accommodation bases calendar (6 hours a day), including pedagogical activities in a formal and non-formal

















- education format, and playful activities in relation with the selected thematic (theatre, collective games, arts, sports, excursions, etc.)
- Online European Youth Camps on an online educational platform that last for 10 days. It requires development of 8 daily topics on the selected thematic, on an online base (5 hours a day), including pedagogical and online non-pedagogical activities related to the thematic.

The pedagogical programmes will also be adapted to be used on a mobile application, used during the camps and afterwards. This adaptation will contain summaries of the information and a selection of digital games and quizzes linked to each thematic. The Mobile application is already developed by the Institut français d'Ukraine.

You have to develop a methodology for offline and nomad European Youth Camps. However, in case of sanitary restrictions due to the pandemic of COVID-19, we will ask you to develop a methodology for online format.

5. What are the partner's tasks?

- Selection of the thematics and development of the daily topics of the pedagogical programmes in cooperation with the Institut français d'Ukraine for all mentioned formats
- Development of daily calendar and detailed activities for all mentioned formats, including necessary information on the selected topics, pedagogical and non-pedagogical activities related to the thematic for the targeted age group
- Adaptation of the pedagogical programmes to the mobile application, in cooperation with the Institut français d'Ukraine and its representative:
 - Creation of playful summarised informational contents (pdf or other digital format) for each daily topic.
 - Creation of up to 10 contents of quizzes and games based on the pedagogical programme for each daily topic (the format and list of available games is already developed by the Institut français d'Ukraine and will be communicated to the partner up to 6 different formats)
 - Work in cooperation with the Institut français d'Ukraine and its representative to create and adapt the digital accessories: badges, rules, legend of the programme, etc.

6. What is not included in the partner's tasks?

- Selection of the hosting structures for the camps
- Development of the linguistic modules and activities
- Selection of the participants to the European Youth Camps
- Selection of the service providers for the coordination of the pedagogical programmes
- Selection and development of the digital tools (mobile application and LMS platform if needed)
- Coordination of the different formats of camps

7. What is the timeline of the pedagogical programs development for European Youth Camps?

You will find out whether you were selected in mid-January 2022, and the cooperation will begin immediately. In this context, you should be ready to start the development of programmes in February and to have them ready by mid-March 2022.

- Experience in pedagogical programmes development,
- To be able to be contracted through a service provision convention.
- To be officially registered in Ukraine

- Scanned copy of the extract from the Unified State Register or status documents
- Budget drafted in our template
- Summary of your pedagogical proposition with examples of daily topics, schedule, and activities. The pedagogical proposition should be developed for each thematic.
- Memorandum drafted in our template
- Recommendations (if available)

5 13. How will the partner be selected?

First, all the applications will be checked whether they meet technical criteria and if all the listed information and all the demanded certificates are given. If your application is complaint with that, our experts will access the application according to the following selection criteria:
