



# Call for partners Hosts for nomad European Youth Camps

#### 1. House of Europe

House of Europe is an EU\*1-funded programme fostering professional and creative exchange between Ukrainians and their colleagues in EU\* countries. The programme focuses on different professional fields: culture and creative industries, education, health, social entrepreneurship, media, and youth.

This encompasses 20+ separate programme lines enabling to go for professional events, internships, and networking in the EU\*, or to enrol in study tours, residencies, trainings, and other forms of support. House of Europe funds cultural coproductions and cooperations between Ukrainian and EU\* organisations, along with the development of cultural infrastructure and artistic concepts for youth in Ukraine. Finally, the programme offers various youth camps and an intra-Ukrainian university exchange.

Implementation of House of Europe is led by Goethe-Institut Ukraine, with The British Council, Institut français, and Czech Centres as consortium partners.

#### 2. What is this call about?

We are looking for educational institutions from small cities and villages all over Ukraine to co-organise nomad European Youth Camps, dedicated to tolerance and inclusion and ecology and sustainable development.

Participants of the camps will attend lectures, take part in playful activities, and get initiated to the languages of the EU. The camp is held offline and lasts for five days (six hours each day). No accommodation is provided, lunch is provided on-site.

#### 3. What are the European Youth Camps?

European Youth Camps are summer camps with a focus on values important to European and Ukrainian society. We choose a topic for each session and explain it to children in an interactive way. Among these topics are ecology,

sustainable development, health, tolerance, inclusion, democracy, and innovation. Children learn, make friends and have fun.

The participants also have access to a specially designed mobile application with additional information, quests, and games. The application operates on iOS and Android.

The nomad camps will take place within the premises of local educational institutions in regions of Ukraine. In 2021, the selected topics of the camps are "Tolerance and inclusion" and "Ecology and sustainable development". Other themes will be developed in 2022.

## 4. What is the timeline of the nomad European Youth Camps?

Nomad European Youth Camps will be held during the autumn school vacation: in the last week of October 2021.

You will find out whether you were selected to co-organise the camp at the end of September 2021, while our cooperation will begin in early October. In this context, you should be ready to launch a local open call for participants and start working on the event at the date of selection.

## 5. What are the partner's tasks?

- Provision of the premises for 50 participants and the pedagogical team of about 7 persons
- Provision of the necessary staff for the implementation of the nomad camp: local coordinators, maintenance staff, security staff
- Selection of the participants, using the selection criteria provided by us. We will assist you
- If available, provision of the premises for the meal and one meal a day for all participants and camp staff, using the necessary equipment on place or a catering alternative

# 6. What is not included in the partner's tasks?

- Organisation of the pedagogical coordination
- Selection of the pedagogical team
- Organisation and logistics for the transport, accommodation, and catering for the pedagogical team

## 7. Who can apply?

Educational and cultural institutions:

- Public institutions
- Private organisations
- NGOs

We encourage cooperation between educational institutions from the same area: you can create a local educational cluster. One institution will apply

for the whole cluster, while a memorandum to define the roles and duties of each partner should be concluded before the application.

Local cultural or educational public departments representing local institutions can also apply. In such a case, the institution selected to host the camp should be clearly identified.

#### B. Who cannot apply?

- Political parties
- Private entrepreneurs

## 9. What do you need to apply?

- Premises to host the camp
- Experience in youth work
- To be officially registered in Ukraine
- To be from a city under 300 000 inhabitants
- To be interested in the topics of tolerance and inclusion and ecology and sustainable development

## 10. How do I apply?

Please submit your application along with all the documents via the <u>online</u> <u>platform</u>. Please find the chapter "European Youth Camps", open call "Hosts for nomad European Youth Camps".

The deadline is Monday 27 September 2021, 15:00 Kyiv time.

## 11. What additional documents do I need to provide?

- CV of the person(s) who will be responsible for the coordination
- Scanned copy of the extract from the Unified State Register or status documents
- Documents justifying the availability to host or organise activities with minors
- Budget drafted in <u>our template</u> (if the status of the applying institution allows a service providing convention)
- Recommendations (if available)
- In case of submission by a cultural or educational administration, memorandum on roles and specificities of each institution involved drafted in our template
- In case of submission by a cluster of cultural or educational institutions, memorandum on roles and specificities of each member drafted in our template
- In case of submission by a cultural or educational public institution or a cluster of institutions, a written authorisation for the organisation of the nomad camps from the cultural or educational department to which they belong

















#### 12. How will the partner be selected?

First, all the applications will be checked whether they meet technical criteria and if all the listed information and all the demanded certificates are given.

If your application is compliant, we will evaluate it according to our selection criteria. Selection criteria include experience of educational programmes implementation, international cooperation, relevant cooperation plan with applying partner structures, pedagogically relevant description of the criteria and the plan of the selection of participants, reasonable and feasible budget.

#### 13. How will the partnership be regulated?

All services provided will be contracted through a service providing convention.

Nevertheless, in case of provision of premises without financial compensation, a convention for the use of the premises may be concluded.
