

# House of Europe x Netflix Stipends for filmmakers FAQs

## 1. I have already received your stipend for filmmakers. Can I apply again?

No. We seek to support as many Ukrainian filmmakers as possible: if you received a stipend for filmmakers in 2022 or got a script development grant from the Ukrainian Film Academy in partnership with Netflix, you will not be eligible for a stipend. House of Europe employees and experts evaluating the applications for stipends for filmmakers are not allowed to apply.

## 2. Can I apply for other Netflix opportunities?

We will launch the open calls later this year.


## 3. Currently, I am outside Ukraine. Can I still apply?

If you have Ukrainian citizenship and you have left Ukraine in 2022, please apply.

## 4. I live in Crimea, 'LPR' or 'DPR'. Can I apply?

No, Ukrainian citizens residing in the Restricted Regions of Ukraine are not eligible. 'Restricted Region of Ukraine' refers to the United States sanctioned areas of Ukraine.

## 5. I am not registered as a private entrepreneur. Can you transfer the money to my friend's account?



No, you can only get the money to your private entrepreneur's bank account. We will not be able to transfer the stipend to your family member or friend.

If not registered as a private entrepreneur, ask your partner organisation to get the stipend for you via their LLC, NGO or other legal entity.

#### **6. In which currency will I get the stipend?**

It depends on your country of residency.

Filmmakers that are in Ukraine will get the stipend in UAH. We will convert EUR 1,000 to UAH according to the internal exchange rate of Goethe-Institut. Our rate is defined by the external accounting system, on the day of the transaction, which is guided by the exchange rate of the National Bank of Ukraine.

Filmmakers abroad can receive the stipend to their local account in EUR or another currency. We will transfer the money in EUR, and your bank will convert it into the currency of your account according to its own rate. Do not forget there might be a commission fee.

#### **7. Can I get the stipend for humanitarian needs?**

No, this stipend is for creative projects only. You cannot cover humanitarian expenses or buy military equipment, arms, and ammunition.


Directly or indirectly funding Belarus or Russian public authorities, or entities/people subject to United States, United Kingdom and/or EU sanctions is strictly prohibited.

#### **B. The stipend does not cover all my expenses. What should I indicate in the budget?**

Identify only your priority expenses, which you would like covered by the stipend.

The stipend is EUR 1,000. When planning on funding something exceeding this amount, explain how you will cover the rest of the sum.

Explain why these expenses are urgent now and how coverage of these costs will help you continue your career in the industry.
