



Call for partners to host House of Europe children's camps in Kiev or Kyiv region

House of Europe is looking for local partners to host children's camps in Kyiv or Kyiv region for 50-80 children aged 11-13 and 14-16. Two camps will be held in 2020, one camp in 2021 and 2022 respectively. The duration of each camp is 2 weeks, the first camp is scheduled for May 2020.

The main tasks of the camps

- improve awareness of the EU in the younger generations, foster the development of EU values through project implementation
- promote the study of European languages
- promote awareness of the integrity of the Ukrainian territory among young people
- promote mutual understanding in the multinational and multilingual Ukrainian culture

About House of Europe

House of Europe is a new program funded by the European Union for the professional and creative exchange between Ukraine and the EU in the fields of cultural and creative industries, education, healthcare, media, social entrepreneurship and youth work.

Requirements for the camps

- possibility of settling children, 2-4 children per room
- possibility of accommodating animators and volunteers (up to 10 people) in single rooms
- nutrition according to norms and standards (resolution of the Cabinet of Ministers of Ukraine of November 22, 2004 No. 1591)
- possibility of holding events in the camp (concerts, competitions, competitions, etc.)

















- availability of staff (leaders) who have been trained and certified for work with children
- availability of facilities for events (workshops, discussions, talks etc.)
- availability of staff specialized in conducting creative workshops, sports events, etc. (preferably)
- transfer of children from the station to the camp

Who can apply

- private organizations
- NGOs
- private entrepreneurs

Potential Partner

- is able to provide services according to the list
- is based in Kyiv or Kyiv region
- has experience in organizing and conducting camps for children and young people

How to Apply

<u>Fill out the online application form</u> - answer the questionnaire and attach the documents according to the list:

- estimated budget (Excel file)
- summary of the person who will be responsible for the camp
- a list of personnel to be involved in the camp
- the act of acceptance of the children's health institution (children's health and recreation institution) in the form No. 318 / o, approved by the order of the Ministry of Health of Ukraine dated

















July 11, 2000 No. 160, certified by the seal and signature of the territorial body representative of the State Consumer Service at the location of the participant in 2018-2019

- certificate of state attestation of a children's health and recreation institution, valid at the moment of opening of the tender offers (for participants children's health and recreation institutions) or a copy of accreditation certificate for assignment of a health and recreation institution of a certain accreditation category (for participants and recreation establishments, health facilities Part 4 of Article 14 of the Law of Ukraine "On the health improvement of children")
- certificate of the authorized body for a child's health and recreation facility of the participant presence in the State register of children's health and recreation establishments, except for health and sanatorium / resort establishments, which are not covered by this requirement defined by the Law of Ukraine "On the health improvement of children". Wellness and health resorts provide a copy of the certificate of the authorized body, confirming the circumstances under which the requirement for entry in the State register of children's institutions of health and recreation is absent
- valid certificate of conformity that guarantees catering services in health resort resorts
- valid certificate of conformity, which guarantees the provision of services for short-stay accommodation
- photos of the health and recreation facility

The application deadline is **December 27, 2019**.
